2. Consideration of an Exclusive Negotiation Agreement with Eight88 Hospitality, LLC to negotiate a Master Development Agreement for the development of property within the City located north of Orangethorpe Avenue, south of Fullerton Creek, east of Coyote Creek, and west of Valley View Street

Recommendation that the City Council take the following actions:

- a) Approve and authorize the Mayor to execute an Exclusive Negotiation Agreement with Eight88 Hospitality, LLC to negotiate a Master Development Agreement for the development of property within the City located north of Orangethorpe Avenue, south of Fullerton Creek, east of Coyote Creek, and west of Valley View Street;
- b) Appoint a Negotiating Ad Hoc Committee consisting of two members of the City Council, City Manager, City Attorney, and other City staff and consultants as deemed necessary during the course of the agreement.
