

RESOLUTION NO. 2021-07

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
LA PALMA, CALIFORNIA AMENDING THE START TIME
OF CITY COUNCIL MEETINGS**

WHEREAS, on May 5, 2020, the City Council of the City of La Palma conducted a second reading and adopted Ordinance 2020-02 allowing the City Council to adjust the meeting frequency, dates, and times, by means of Resolution and considered testimony and evidence at the Regular Hearing held with respect thereto; and

WHEREAS, Ordinance 2020-02 went into effect on June 4, 2020, and the City of La Palma evaluated upcoming City business and recognized a decrease in agenda items as a result of closing the economy and the State's plans for a phased reopening; and

WHEREAS, on June 2, 2020, by Resolution 2020-29, the City of La Palma addressed both the reduction in Agenda Items and a desire to continue combatting the public's exposure to COVID-19, and approved a reduction in the meeting schedule from twice a month to once a month, meeting on the first Tuesday of each month at 7:00 p.m., in an effort to manage both issues simultaneously effective June 4, 2020; and

WHEREAS, on October 6, 2020, by Resolution 2020-41, the City Council modified the meeting schedule due to the 2020 General Election and subsequent holiday closure; and

WHEREAS, on January 19, 2021, by Resolution 2021-03, the City Council returned to its standard meeting schedule falling on the first Tuesday of each month by; and

WHEREAS, in an effort to accommodate the likelihood of larger agendas on the monthly meeting schedule, the City Council wishes to modify the start time of the City Council meetings thirty minutes earlier through the adoption of this Resolution.




