REGULAR ITEMS

2. **Request for Traffic Improvements at the Intersection of Amberwood Avenue and Suffield Street**

It is recommended that the Traffic Safety Committee recommend that the City Council approve the request to install striping improvements at the intersection of Amberwood Avenue and Suffield Street and remove the pedestrian ramp at the inner radius of the knuckle of the subject intersection.

3. **Request for Traffic Improvements at the Crescent Avenue/Watson Street Crosswalk**

It is recommended that the Traffic Safety Committee take the following actions:

1. Recommend that the City Council approve the restriping of the crosswalk of the north/south crosswalk in thermoplastic
2. Recommend that the City Council approve the installation of a pedestrian ramp at the north end of the crosswalk
3. Recommend that the City Council approve the submittal of an application for the installation of in-road warning lights through the Safe Routes to School funding source administered by Caltrans.
